WorkForce West Virginia

WorkForce West Virginia is a state agency funded through the U.S. Department of Labor that oversees the state unemployment insurance program as well as a network of workforce development services designed to provide West Virginia's citizens and employers the opportunity to compete in today's global economy. WorkForce West Virginia is a one-stop center for workforce resources, including the following employer services:

- **Find Qualified Workers** - WorkForce West Virginia provides employers with 24/7 access to the state's largest online database of potential job candidates, the Mid-Atlantic Career Consortium (MACC). Through this portal, employers can post active job listings and receive and review applications. To submit a Job Order, email: workforcejobs@wv.gov
- **Training for Employers**- Depending upon your specific workforce needs, we can help you determine the best education or training program, locate viable candidates to participate in training and even arrange on-the-job training for employees.
- **Business Services Team**- WorkForce West Virginia can help connect you with business services in your local community to meet and address a variety of immediate and long-term company needs, including access to available workforce training programs in your local community.
- **Unemployment Process**- WorkForce West Virginia provides companies with unemployment processing assistance. Employers can register businesses, file quarterly wage reports, make contributions and delinquent payments, and register for electronic submission of separation information.
- **Labor Market Information**- Find information relating to the Labor Force, Occupational Information, Industry Data, and Top Employers.
- **Layoff Aversion Resources**- Layoff aversion is currently conducted by the West Virginia Development Office (WVDO). Layoff Aversion is conducted by the State Rapid Response team and provides employer outreach and strategies prior to a layoff, or when a Worker Adjustment and Retraining Notification (WARN) is received.

FEDERAL BONDING PROGRAM

The Federal Bonding Program (FBP) provides Fidelity Bonds to the employer that guarantee honesty for at-risk hard-to-place, and criminal justice involved job seekers. The bonds cover the first six months of employment. There is no cost to the job applicant or the employer. This unique hiring incentive tool targets individuals whose backgrounds can pose significant barriers to securing or retaining employment including:

- Justice-involved men, women, and youth
- Individuals in recovery from substance abuse
- Temporary Assistance for Needy Families (TANF) recipients
- Individuals with poor credit records
- Economically disadvantaged youth and adults with little or no work histories
- Individuals dishonorably discharged from the military.

Employers receive the bonds free-of-charge as an incentive to hire these applicants. The FBP was designed to reimburse the employer for any loss due to employee theft of money or property up to \$10,000 during the first six months of a selected individual's term of employment.

WORK OPPORTUNITY TAX CREDIT (WOTC)

The WOTC is a federal tax credit program that offers significant incentives for employers who hire and retain individuals from specific target groups that have previously experienced difficulty in securing employment.

Program Benefits

Through this program, employers can:

- Receive tax credits for hiring individuals from targeted groups
- Reduce federal tax liability by as much as \$2,400 per new hire during the first year of employment
- Help those most in need to become economically self-sufficient
- Hire as many qualified employees as the payroll will allow
- Reduce recruitment and training costs
- Claim the tax credit with minimal paperwork
- Provide valuable on-the-job experiences to qualified job seekers

MILITARY INCENTIVE PROGRAM

A West Virginia State Tax Credit for Employers Who Hire Qualified Veterans

The Military Incentive Program (MIP) Act of 1991 created an employer tax incentive program designed to promote the employment of West Virginia veterans, reservists and National Guard members. Korean conflict and Vietnam era veterans who are economically disadvantaged, and all other disabled veterans are covered by this program. Region VI Workforce Development Board

The Region VI WDB provides Workforce Innovation and Opportunity Act (WIOA) funded training services to employers located in the Region VI service area, which includes the following counties: Barbour, Braxton, Doddridge, Gilmer, Harrison, Lewis, Marion, Monongalia, Preston, Randolph, Taylor, Tucker, and Upshur.

On-The-Job Training

- Training of a new hire or upskilling of a current employee;
- Training for permanent, full-time employees (full time defined as working a minimum of 30 hrs. a week);
- Training for which the employer pays for not less than 50% percent of the hourly wage (will only fund positions that pay \$12 hr. or better);
- Max training period of 480 hours.

Customized Training

- Training designed to meet the needs of an employer (including a group of employers);
- Training which relates to the introduction of new technologies, introduction to new production or service procedures, upgrading to new jobs that require additional skills, workplace literacy, or other appropriate purposes identified by the Local Board;
- Training for which employers pay for not less than 50% percent of the cost of training.

Incumbent Worker Training

- Training designed to meet the special requirements of an employer (or group of employers) to retain a skilled workforce, assist in business expansion or avert a layoff;
- Employee/s has an established employment history with the employer for 6 months or more.

Transitional Training

- May utilize Transitional Training to provide prospective employees with a 100% subsidized short-term period of employment, which could transition into permanent employment under an OJT contract.
- A transitional job is one that provides a limited work experience, that is subsidized in the public, private, or non-profit sectors for those individuals with barriers to employment because of chronic unemployment or inconsistent work history; these jobs are designed to enable an individual to establish a work history, demonstrate work success, and develop the skills that lead to unsubsidized employment.

By design, these programs connect and support meaningful career pathways that can move a participant from foundational level trainings into advanced certificate and degree programs. With direct input from business and industry, Career and Corporate Training collaborates to develop highly skilled workers poised for gainful employment, salary increases, and advancement.



The Learn & Earn program offers students the opportunity to gain valuable work experience while completing their 1- or 2-year technical degree or approved training program at Pierpont. This state funded workforce initiative through the West Virginia Community and Technical College System creates regional partnerships between industry and education, building a pipeline for qualified future employees. Pierpont's Career and Corporate Training office administers the Learn & Earn Program for North Central WV.

- ✓ Employers receive 50% base wage reimbursement
- ✓ Student workers paid min. wage of \$ 12/hour (per state code)
- ✓ Employers provide supervision/mentorship, identifying outcomes expected
- ✓ Students are temporarily employed up to one year; avg. 20-25 hours per week
- ✓ Pierpont Community & Technical College will identify and assist in selecting student workers, process and manage the reimbursement funding, and provide administrative support throughout the program period

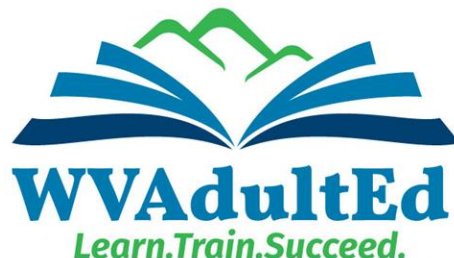

The Division of Rehabilitation Services (DRS) is a comprehensive employer assistance program for business owners and employers. Our goal is to assist business owners and employers with disability-related issues. DRS can provide you with critical business options in the areas of staffing, education, tapping into financial incentives associated with hiring a person who has a disability, or insuring accessibility to your goods and services.

Staffing assistance for your business

Business owners and employers can benefit from the following free DRS business solutions:

- **Recruitment:** Our Employment Specialists will match businesses with qualified job seekers from the DRS consumer database. Email your vacancy announcements directly to DRS staff for statewide or local distribution.
- **On-the-Job Training:** Funding is available to employers through DRS to assist with the costs associated with training a qualified job seeker from our consumer database.
- **Job Try-Out Program:** This no-cost trial work opportunity program is an opportunity for job-ready applicants to perform standard work requirements and display work skills for an employer.
- **Accessibility Assessments:** Employee turnover is expensive. It is more cost-effective to keep an existing employee who develops or incurs a disability as part of your workforce by making reasonable workplace accommodations. Employment Specialists can provide:
 - Job Analyses
 - Site Evaluations
 - Jobsite Accommodation Consultation
- **Placement Services Program:** DRS contracts with community vendors to provide services that help employees become acclimated to or increase their ability to perform the duties of their job. Contracted services may include job coaching, job retention, social skills training, job placement, etc.
- **Job Retention Services:** A business may have a great employee whose work performance has changed due to gradual loss of hearing or vision, accident, or illness, or any other physical or mental impairment that affects work performance. DRS can assess individual needs, assist with expenses for vocational rehabilitation and recommend workplace solutions to retain an employee who is at risk of losing his or her job because of a disability.

Tax credits and hiring incentives

In today's highly competitive global market, the bottom line is the most important factor for business owners and employers.

There are three federal tax incentives available to assist employers with the cost of accommodations for employees with disabilities and to assist with the cost of making their place of business accessible to employees and to customers with disabilities.

- **Work Opportunity Tax Credit:** Federal tax credit for employers who hire employees with disabilities through DRS. The credit applies to the first \$6,000 of wages paid. (IRS Form 8850)
- **The Disabled Access Tax Credit:** Geared toward eligible small businesses to meet any increased expenses incurred in complying with the Americans with Disabilities Act. The allowable amount of the tax credit is equal to 50 percent of the expenditures in excess of \$250, but not more than \$10,250. (IRS Form 8826 — Disabled Access Credit, or Part 1, Line 1 of Form 3800 — General Business Credit)
- **The Barrier Removal Deduction:** A business may deduct up to \$15,000 per tax year for making its premises or public transportation vehicles more accessible. (Title 26, IRS Code, Section 190)

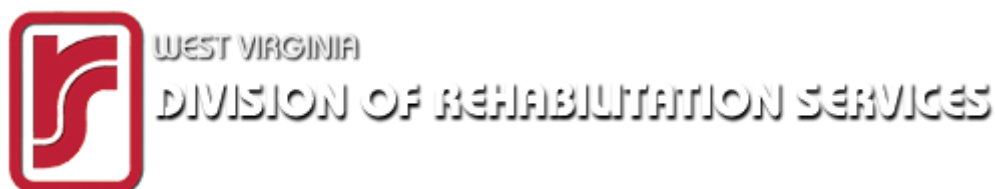
